- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses,

- schedules or appendices of this privacy policy;
- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Helen Burgess and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Helen Burgess is the "data controller". This means that Helen Burgess determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data, which includes personal Data, from you:
 - a. name;

How we collect Data

- 6. We collect Data in the following ways:

 - b. data is collected automatically.

Data that is given to us by you

- 7. Helen Burgess will collect your Data in a number of ways, for example:

Data that is collected automatically

Our use of Data

- 11. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.

Who we share Data with

- 12. We may share your Data with the following groups of people for the following reasons:

 - b. relevant authorities to facilitate the detection of crime or the collection of taxes or duties:

Keeping Data secure

- 13. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.

Data retention

Your rights

- 24. We may also disclose Data to a prospective purchaser of our business or any part of it.
- 25. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

Cookies
